- 13.3 The documentary evidence of the bidder's qualifications to perform the contract if its bid is accepted shall establish to the Procuring agency's satisfaction:
 - (a) that, in the case of a Bidder offering to supply goods under the contract that the bidder did not manufacture or otherwise produce, the bidder has been duly authorized by the goods' Manufacturer or producer to supply the goods in the Procuring agency's country.
 - (b) that the bidder has the financial, technical, and production capability necessary to perform the contract.
 - (c) that, in the case of a Bidder not doing business within the Procuring agency's country, the bidder is or will be (if awarded the contract) represented by an Agent in that country equipped, and able to carry out the Supplier's maintenance, repair, and spare parts-stocking obligations prescribed in the Conditions of Contract and/or Technical Specifications; and
 - (d) that the bidder meets the qualification criteria listed in the Bid Data Sheet.

14. Documents Establishing Goods' Eligibility and Conformity to Bidding Documents

- 14.1 Pursuant to ITB Clause 9, the bidder shall furnish, as part of its bid, documents establishing the eligibility and conformity to the bidding documents of all goods and services which the bidder proposes to supply under the contract.
- 14.2 The documentary evidence of the eligibility of the goods and services shall consist of a statement in the Price Schedule of the country of origin of the goods and services offered which shall be confirmed by a certificate of origin issued at the time of shipment.
- 14.3 The documentary evidence of conformity of the goods and services to the bidding documents may be in the form of literature, drawings, and data and shall consist of:
- (a) a detailed description of the essential technical and performance characteristics of the goods.
- (b) a list giving full particulars, including available sources and current prices of spare parts, special tools, etc., necessary for the proper and continuous functioning of the goods for a period to be specified in the Bid Data Sheet, following the commencement of the use of the goods by the Procuring agency; and,
- (c) an item-by-item commentary on the Procuring agency's Technical Specifications demonstrating substantial responsiveness of the goods and services to those specifications, or a statement of deviations and exceptions to the provisions of the Technical Specifications.
- 14.4 Specifications the commentary to be furnished pursuant to ITB Clause 14.3(c) above, the bidder shall note that standards for workmanship, material, and equipment, as well as references to brand names or catalog numbers designated by the Procuring agency in its Technical

- 24.4 Prior to the detailed evaluation, pursuant to ITB Clause 25 the Procuring agency will determine the substantial responsiveness of each bid to the bidding documents. For the purposes of these Clauses, a substantially responsive bid is one which conforms to all the terms and conditions of the bidding documents without material deviations. Deviations from, or objections or reservations to critical provisions, such as those concerning Bid Security (ITB Clause 15), Applicable Law (GCC Clause 30), and Taxes and Duties (GCC Clause 32), will be deemed to be a material deviation. The Procuring agency's determination of a bid's responsiveness is to be based on the contents of the bid itself without recourse to extrinsic evidence.
- 24.5 If a bid is not substantially responsive, it will be rejected by the Procuring agency and may not subsequently be made responsive by the bidder by correction of the nonconformity.

25. Evaluation and Comparison of Bids

- 25.1 The Procuring agency will evaluate and compare the bids which have been determined to be substantially responsive, pursuant to ITB Clause 24.
- 25.2 The Procuring agency's evaluation of a bid will be on delivered duty paid (DDP) price inclusive of prevailing duties and will exclude any allowance for price adjustment during the period of execution of the contract, if provided in the bid.
- 25.3 The Procuring agency's evaluation of a bid will take into account, in addition to the bid price quoted in accordance with ITB Clause 11.2, one or more of the following factors as specified in the Bid Data Sheet, and quantified in ITB Clause 25.4:
 - (a) incidental costs
 - (b) delivery schedule offered in the bid.
 - (c) deviations in payment schedule from that specified in the Special Conditions of Contract.
 - (d) the cost of components, mandatory spare parts, and service.
 - (e) the availability of Procuring agency of spare parts and after-sales services for the equipment offered in the bid.
 - (f) the projected operating and maintenance costs during the life of the equipment.
 - (g) the performance and productivity of the equipment offered; and/or
 - (h) other specific criteria indicated in the Bid Data Sheet and/or in the Technical Specifications.
- 25.4 For factors retained in the Bid Data Sheet pursuant to ITB 25.3, one or more of the following quantification methods will be applied, as detailed in the Bid Data Sheet:
 - (a) Incidental costs provided by the bidder will be added by the Procuring agency to the delivered duty paid (DDP) price at the final destination.
 - (b) Delivery schedule.
 - (i) The Procuring agency requires that the goods under the Invitation for Bids shall be delivered at the time specified in the Schedule of Requirements which will be treated as the base, a delivery "adjustment" will be calculated for bids by applying a percentage, specified in the Bid Data Sheet, of the DDP price for each week of delay beyond the base, and this will be added to the bid price for evaluation. (c) Deviation in the payment schedule.

(i) Bidders shall state their bid price for the payment schedule outlined in the SCC. Bids will be evaluated on the basis of this base price. The Procuring agency may consider the alternative payment schedule offered by the selected bidder.

(f) Operating and maintenance costs.

(g) Performance and productivity of the equipment.

(i) Bidders shall state the guaranteed performance or efficiency in response to the Technical Specification. For each drop in the performance or efficiency below the norm of 100, an adjustment for an amount specified in the Bid Data Sheet will be added to the bid price, representing the capitalized cost of additional operating costs over the life of the plant, using the methodology specified in the Bid Data Sheet or in the Technical Specifications.

(ii) Goods offered shall have a minimum productivity specified under the relevant provision in the Technical Specifications to be considered responsive. TERMS OF REFERENCES/SCOPE OF WORK

BACKGROUND

During the surge of Rain-flood; there is an emergency situation in Sindh. The school buildings have closed BUT education and learning should not stop and should continue in a safe environment.

To support this continuity in a safe environment and ensure that all people in school communities (students, teachers, other education personnel, parents) have the information that they need to protect students, teachers and other education staff, and the wider community (family, friends) during the floods from the hazards of floods and coronavirus in their temporary/shelter schools to keep the learning process continued, effectively for children of IDP families in established Temporary Learning Centers (TLC).

So, a campaign is needed to make aware the community, parents, teachers, and education officials also as an admission retention drive. Keeping the view that Education is the right of every child, be it a boy or girl, and should not stop even in emergencies and treat it as a top priority while keeping the students, teachers, school managers, and other staff safe. With UNICEF's support, the Government designed SOPs and guidelines for school managers, children, parents, and communities, which can be used to improve the plan for education continuity. SE&LD, with the support of UNICEF, SE&LD reached out to the parents and communities through different media platforms and by disseminating informative material that will help gain the parents' confidence to send their children to TLC shelter school and motivate them for getting their children admission to TLC. using the radio as a media platform so that the message reaches areas where the internet/ television and other technologies are hardly available.

ASSIGNMENTS:

To achieve the objective Reform Support Unit, SE&LD is looking for a capable and experienced media communication firm for the following assignment.

- 1. Raising awareness to ensure that people in school communities (students, teachers, other education personnel, and parents) must understand the importance of continuity of education and learning during emergencies because Schools are safe spaces for children during emergencies.
- 2. Several Radio Data Communication (Spots): Up to 12 (Twelve) spots per day, the duration of each spot (voiceover) may be between 60-90 seconds duration.
- 3. Target Audience: Parents, Community, Teachers, and Students.
- 4. Preferred Channel for Air: FM Radio has comprehensive coverage across the province.

THE OBJECTIVE OF THE ASSIGNMENT:




