1. Meeting Details:

A meeting of the Procurement Committee was held at the Reform Support Unit, School Education and Literacy Department (RSU-SE&LD) Head Office on 23rd July 2024 at 4:30 PM. The purpose of the meeting was to open bids for the repair, renovations, and calligraphy/artwork of ECCE classrooms in the Sujawal District, Sindh Province.

2. Purpose of Procurement:

The procurement is for the "Repair, Renovations, and Calligraphy/Artwork of ECCE Classrooms in Sujawal District, Sindh Province" under the Rolling Work Plan of the Sindh Education Sector Plan & Roadmap 2019-24. The procurement method used and approved by the competent authority was Open Competitive Bidding (NCB) Rule No. 15 (1)(b) and Single Stage One Envelope Procedure Rule No. 46 (1) of SPPRA 2010 (amended to date).

3. Opening Prayer:

The meeting commenced with the recitation of the Holy Qur'an.

4. Chairmanship:

The meeting was chaired by Mr. Junaid Hameed Samo, Chief Program Manager (CPM), RSU-SE&LD. The Chairman welcomed and thanked the members and invited the Procurement Specialist-SESP/RWP to brief the participants about the procurement proceedings to date.

5. Approval and Announcement:

It was informed that the competent authority approved the bidding documents and announcement of the Invitation for Bid (IFB) on 1st July 2024 (attached at Annex-A). The IFB was sent to the Director Advertisement, Information & Archives Department, Government of Sindh, for publication in leading newspapers via letter #RSU-SE&LD/UNICEF/SESP/RW/NCB (01)/2024 dated 1st July 2024 (attached at Annex-B).
