The Reform Support Unit, School Education and Literacy Department, Government of Sindh has received Grant from the Federal Government of Pakistan towards the cost of Pakistan address school disruptions due to COVID-19 by accelerating virtual and distance learning opportunities for out-of-school children, particularly among disadvantaged communities and intends to apply part of the proceeds for inviting tenders from well-reputed SMS Broadcast Services providing firms/company registered with Income Tax Department and Sindh Revenue Board and having five-year relevant experience.

- 1. Bidding shall be conducted through Open Competitive Bidding (Single Stage-Two Envelopes) procedures specified in Rule No. 46 (2) of SPPRA Rules 2010 (Amended to date) and is open to all eligible bidders as defined in the bidding document.
- 2. Shortlisting of the desired Bidder will be based on criteria mentioned Bidding Document (BD) with 70% minimum passing score.
- 3. Interested eligible Bidders may obtain further information from Reform Support Unit, Bangalow # 47-E/1, Street# 48, PECHS-6, Shahrah-e-Faisal, Karachi, Sindh, and inspect the bidding documents from 09:00 Hrs. to 16:00 Hrs. Monday to Friday, exclusive holidays.
- 4. Any interested eligible bidder may obtain a complete set of bidding documents upon submitting a written application to the above office and upon payment of a non-refundable amount of Rs. 500/-(Five Hundred only) in the form of a Demand Draft / Pay Order in favour of the Chief Program Manager, Reform Support Unit, School Education & Literacy Department, Government of Sindh or can be downloaded from the Website https://rsu-sindh.gov.pk/downloads/tenders.php & https://ppms.pprasindh.gov.pk/PPMS Bidders who download the document from the Website and wish to participate in the bid will be required to submit the cost of the bid document at the time of bid submission; otherwise, the bid will be considered non-responsive.
- 5. Bids must be delivered before the time, date, and address provided above. Late submissions will be rejected. Bids will be opened in the presence of bidders' representatives who choose to attend the bid opening ceremony. The financial bids will be opened before technically qualified firms/suppliers, and they will be informed in due course of time accordingly.
- 6. To avoid overcrowding at the public bid opening meeting, only one representative of a participating bidder wearing a COVID-19 protective mask shall be allowed to attend the meeting.
- 7. Bids must be accompanied by bid security from a reputed bank, whether local or international. The amount of Bid Security required is 2% of the total bid amount in a pay order /demand draft favouring Reform Support Unit, School Education & Literacy Department, Government of Sindh.
- 8. The Procuring Agency may reject all or any bid or proposal at any time prior to the acceptance of a bid or proposal. Subject to the relevant provision of SPPRA Rules, 2010 (Amended to date). The Procuring Agency, upon request, communicates to the bidder who submitted a bid or proposal the grounds for its rejection of all bids or proposals but is not required to justify those grounds.
