### (b) TERMS OF REFERENCES (TORs)

### **BACKGROUND:**

COVID-19 outbreak critically impacted the educational systems across the province. This pandemic disrupted the teaching and learning processes due to the closure of educational institutions in February 2020 to reduce the spread of the virus in the best interest of teachers and student's health and well-being.
