- 4- The bidders shall quote each package separately and evaluation of bids shall be done package-wise and contracts will be awarded accordingly.
- **5-** The eligibility criteria for the assignment is as follows:
  - a. Bidder must be an original equipment manufacturer (OEM) or an authorized agent/partner/dealer of the OEM of required equipment in Pakistan.
  - b. Bidder should have documented track of at least 03 (three) similar assignments, during last 05 (five) years, involving the supply, installation, and provision of technical support of a comparable scale;
  - c. Bidder must have verifiable presence/support/branch at Karachi.
  - d. Bidder must have Annual Sales Volume/Gross Turnover of at least 50 million rupees for Packages I, II, & III respectively and 30 million rupees for remaining packages, in any of last 03 (three) years;

- e. Bidder must be registered with Income Tax and Sales Tax Department.
- 6- A complete set of bidding documents may be obtained by any interested eligible bidder on the submission of a written application to the above office and upon payment of a non-refundable amount of Rs. 1000/- (One thousand only) in the form of a Demand Draft / Pay Order in favour of Chief Program Manager, Reform Support Unit, School Education Department, Government of Sindh or can be downloaded from the Website <a href="www.rsu-sindh.gov.pk">www.rsu-sindh.gov.pk</a>. Bidders who download the document from Website and wish to participate in the bid, will be required to submit the cost of the bid document at the time of bid submission otherwise the bid will be considered non responsive.
- 7- The Provision in the Instruction to Bidders in the General Conditions of Contract are the provisions of the World Bank *Standard Bidding Document: Procurement of Goods for National Competitive Bidding, Pakistan*, Part One. Procurement shall be done through National Competitive Bidding (NCB) method in accordance with paragraph 3.3 of Guidelines Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers (January 2011).
- 8- Bids must be delivered on before the time, date and address provided below. Late bids will be rejected. Bids will be opened in the presence of bidders' representatives who choose to attend at the time and address below.
- 9- Bids must be accompanied by a bid security from a reputed bank whether local or international. The amount of Bid Security required is 2 % of the total Bid Amount in PKR or a freely convertible currency in favour of Chief Program Manager, Reform Support Unit, School Education Department, Government of Sindh
- 10- All bidders shall be required to submit with their bid, information on their eligibility and qualification as per the Bid Data Sheet included in the bidding document.
