Bidders who download the document from Website and wish to participate in the bid, will be required to submit the cost of the bid document at the time of bid submission otherwise the bid will be considered non responsive.
- 7- The Provision in the Instruction to Bidders in the General Conditions of Contract are the provisions of the World Bank *Standard Bidding Document: Procurement of Goods for National Competitive Bidding, Pakistan*, Part One. Procurement shall be done through National Competitive Bidding (NCB) method in accordance with paragraph 3.3 of Guidelines Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers (January 2011).
